Minutes of Meeting No. 1710

- 1. President Rtn. Lalita C. Thapa called the virtual RCP Meeting No. 1710 through 'Google Meet' to order with 15 seconds of 'Silent Invocation' for world peace, health and happiness.
- 2. Guests welcomed by the President: Rotaract Club of Patan IPP Rtr. Peshal Bhattarai
- 3. The last meeting minutes were reviewed and adopted.
- 4. Pledges of 'Happy News/Sunshine' contribution and to the Operational Fund marked as 'OF':
 - Rtn. Ramesh L. Maskay for 'Happy Birthday' (NRs. 1,000).
 - Rtn. Lalita C. Thapa for her last but two meetings as President (NRs. 500).
 - Rtn. Bijaya L. Shrestha for a successful Inner Wheel District training programme (NRs. 500).
 - Rtn. Kiran Thapa for 'World Elder Abuse Awareness Day' (NRs. 500).
 - Rtn. Nirmal K. Pradhanang for the birthdays of his twin granddaughters on 6 June (NRs. 1,000).
 - Rtn. Rabendra R. Pandey for resuming the sport of Golf after the lockdown relaxation (NRs. 500).
 - Rtn. Kedar B. Shrestha for good participation in today's virtual meeting (NRs. 500 to OF).
- 5. Rotary News/Information:
 - The RCP's contribution of NRs. 200,000 through the District to the Government's Covid-19 pandemic fund pledged earlier has been made. Contribution to the Nepal Orthopaedic Hospital of NRs. 100,000 has also been made. Members who had pledged to contribute are reminded to reimburse the RCP as soon as possible.
 - The membership dues (NRs. 25,000 per member) also need to be paid before 1 July 2020 by all members.

- President Rtn. Lalita C. Thapa, PDG Rtn. Tirtha M. Sakya, and President Elect Rtn. Nirmal K. Pradhanang briefed on various virtual programmes/meetings arranged by our District:
 - Grant Management Seminar
 - 'Bhajan' programme in memory of RI President Nominee Sekhar Mehta's late father

- Strategic Planning Workshop
- Rotary Nepal Literacy Mission presentation and related meetings with the Education Minister and another one planned with the Health Minister.
- President Rtn. Lalita C. Thapa mentioned, as also suggested by Rtn. Keshab B. Mathema, that the RCP's in-house resources should be used more often for briefings to enrich our members on various topics such as on violence against women, Millennium Challenge Corporation (MCC), government budget and foreign relations (in view of current issues being highlighted by various media) and explore opportunities that these would provide for future work of the RCP.

Rtn. Kiran Thapa added that if RCP wants the issue of 'violence to women' by men as a strategic issue to be incorporated in all our projects (not just guest speakers remind us of it once in a while, with no long term consequence), it would it be a good move if we frame our own gender strategy to guide every project we undertake. As we learn from implementing these projects, we will have the actual data to understand the evolving patterns to determine gender relationships and the power relations between men and women, and other disadvantaged groups such as 'dalits' and 'untouchables'.

- PDG Rtn. Tirtha M. Sakya confirmed that the District is contributing one crore Nepalese Rupees to support the government's efforts on Covid-19 pandemic. Shortfall between contributions raised from clubs and the pledged amount will be covered from the District's disaster relief funds.
- Rtn. Siba B. Rajbhandary updated that Nepal has become the highest recipient of global grants worldwide with US \$4.4 million approved for 35 projects this year.
- Virtual Rotary International Convention 20-26 June 2020: Please refer to Lalitdhara 1357of 25 May 2020 for suggestions to register, which is free of cost.
- Following discussion on the pro and cons of different virtual mechanisms for our meetings during the Covid-19 pandemic, it was agreed to use 'zoom' with subscription to avoid its forty minutes time limit. Rtn. Khadak S. Bisht volunteerd to start the subscription for 'Zoom' meetings from next week. It was also noted that a protocol with 'Do's and Don't's' for a more efficient management of virtual meetings would be helpful.
- Next weekly meeting will be the 5th club assembly of this Rotary Year, led by the current President and the 1st club assembly of the next Rotary Year, led by the President Elect.
