- President Rtn. Mahendra Thapa informed about the following:

Celebration of the RCP's 1,800th regular weekly meeting

President Rtn Mahendra B. Thapa welcomed all the RCP members and spouses for the celebration of the RCP's 1,800th regular weekly meeting followed by a fellowship dinner hosted by him and his spouse, the first lady.

Rtn. Preeti Khemka conducted this part of the meeting with requests to all the Past Presidents to take their turn and talk only for a couple of minutes highlighting any topics from among the most challenging situation, noteworthy achievement, suggestion to the President of the forthcoming year, or interesting anecdote to share recalling their Presidency of the RCP. Taking into account the time constraints, this forum would continue in the next weekly meetings to hear all the Past Presidents.

In today's meeting, there was enough time for six Past Presidents to speak starting from the Charter Secretary of the RCP, Rtn. Matsyendra L. Kayastha. He briefed on how he joined Rotary and together with late Rtn. Kamalmani Dixit, they established the Rotary Club of Patan in 1985. He has been the only Past President who has served for three years as President in the RCP. He has been one of the initiators of the RCP's flagship project, PEEF, which has been very successful in providing scholarship support to economically poor students of public schools in Lalitpur District since 1991.

Past President Rtn. Gabriele Mallapaty (Rotary Year 2018-2019) acknowledged that a presidency can only be as good as its club members. She spoke about her successful efforts to streamline the club's financial management to reduce administrative costs and initiating a good system of annual plans.

Past President Rtn. Jamuna K. Tamrakar (Rotary Year 2011-2012) highlighted the smooth management of the club that needed a venue change, introduction of a major increase in the meeting attendance fee, and a change of the office assistant of the club.

Past President Rtn. Yagya B. Shrestha (Rotary Year 2002-2003) joined Rotary in 1993. During his time, the RCP sponsored 3 new clubs. He had been on the Board of Nepal Orthopaedic Hospital for 6/7 years and was instrumental in expanding that institution with the RCP's support and fund-raising efforts.

Past President Rtn. Kamal B. Nyachhyon (Rotary Year 2000-2001) talked about the efforts to establish the Senior Citizens' Home sponsored by the RCP with donor support from Germany. The venture was successful for many years, but recently it had to be closed for various reasons including funding.

Past President Rtn. Bijaya Mallapaty (Rotary Year 2016-2017) talked about priority given to fellowship and service with eight global grants and internally funded projects totalling over US \$740,000. He highlighted the unique global grant project of providing micro-hydroelectricity to the village of Chepel worth over US \$100,000 wherein the government of Nepal contributed US \$37,500, which was unprecedented.
