- **7.** Before the adjournment of the meeting by the President a.i., the Secretary announced: contributions to Sunshine Fund NRs. 3,550, attendance: members 16, Rotaracts 15, spouse 1 and make-up 10.

Decisions/Minutes of the RCP's 9th Board Meeting of RY 14-15 held on 7 March 2015

The 9th Board Meeting was chaired by President a.i. Matsyendra L. Kayastha and hosted by himself and Rtn. Chandralekha Kayastha (unable to join due to foot fracture). The 'House' noted the information and endorsed/approved the decisions of the Board as follows:

- 1. Decisions of the 8th Board Meeting were reviewed.
- 2. The proposal to proceed with a Global Grant proposal for the NGO Child Protection Centers and Services (CPSS) was approved together with RCP's contribution of US \$100 and opening of a separate bank account. It was suggested to have Rtn. Nirmal Pradhanang as the Primary Contact and Rtn. Satya Pradhan and Rtn. Dr. Bishwa B. Sharma as secondary contacts for this project.
- 3. Approval was also confirmed for a Global Grant proposal for the Paediatric ICU at the Cleft and Burn Centre in Kirtipur with RCP's contribution of US \$100 and opening of a separate bank account. It was suggested to have Rtn. Kedar B. Shrestha as the Primary Contact and Rtn. Padam L. Maharjan and Rtn. Lalita Thapa as secondary contacts for this project.
- 4. Rtn. Gabriele Mallapaty presented a status of all approved and planned Global Grant Projects of the RCP.
- 5. The proposal of a new Member, Mr. Ramesh L. Maskey, introduced by Rtn. Shiva K. Pradhan, was approved for presentation to the next 'House' meeting.
- 6. Banks deduct 15% tax on interest paid to the RCP on all its bank accounts savings and fixed deposits. While this can be claimed back on a quarterly basis, particularly since RCP's documentation of registration at all levels are up to date, it is a very difficult process and has never been done. Board agreed to Rtn. Bijaya Mallapaty's proposal to try to claim the refunds using the services of a group coordinated by Office Assistant Basant Ale Magar. The RCP would cover actual cost and pay a fixed percentage of refund received (to be determined) as service charge to the Group.
- 7. Upon successful completion of the Matching Grant Project for water and sanitation in Mirge, Dolakha, it was agreed to close its bank account No. 008000551 SR with Century Commercial Bank. The Board also thanked Rtn. Gabriele Mallapaty for all the work done for this project.
- 8. It was also agreed to close the RCP's Account No 00405010034164 with Nepal Investment Bank.
- 9. District Awards preparation guidelines were very clear this year and have been distributed to all the Chairpersons of the Committees of the RCP. All Chairpersons were requested to take lead and work on this by 15 April 2015.
- 10. Calendar of important forthcoming events:
 - 16 March talk programme (suggestion on possible speakers are requested).
 - 23 March visit of 'KOSHISH' District Grant Project partners to the weekly meeting.
 - 27/28 March 'PETS' training (dates need to be confirmed by the District).
