May the Laugh Bug Bite You @@@@@

A father left 17 elephants as an asset for his three sons. When the father passed away, his sons opened up the 'Will'. The 'Will' of the father stated that the eldest son should get half of the 17 elephants. The middle son should be given 1/3rd of the 17 elephants and the youngest son should be given 1/9th of the 17 elephants.
