- The last meeting minutes were reviewed and adopted.
- 4. 'Happy News' Contributions:

- 5. Other Contributions:
  - Rtn. Kedar B. Shrestha handed over to the Club President a cheque of Rs. 50,000 as his annual contribution (for the year 2022-23) to the KPAD Fund.
  - Rtn. Rabendra R. Pandey confirmed the payment of his contribution of US \$10,000, as pledged earlier, to The Rotary Foundation for Major Donor Level II.
- 6. Rotary Information:
  - Four wheelchairs have been received by the RCP from the District following the handover ceremony in the presence of
    over 70 Rotarians from Taiwan. These will be given to people with disability based on the recommendation of the RCP's
    KPAD committee.
  - Rtn. Madhu Gadde from RC Arlington briefed on RC Arlington, Seattle, USA, and their social support programmes.
- 7. Today's main programme: Mr. Dinesh Shrestha, Guest Speaker from FNCCI was introduced by Rtn. Pushkar M. Shakya. He is the Vice President (Industry) of the FNCCI of Nepal responsible for industry and commerce development areas.
  - Mr. Shrestha talked about current government policies and the role of FNCCI. He flagged the issues related to control of businesses in Nepal unlike in other developed countries.
  - Mr. Shrestha also talked about the difficulties associated with remote and semi-urban areas in Nepal. On the investment area, he noted that registration fee is too high with tax rates being the highest in South Asia. He also briefed on the current mechanisms of bank loan, interest rates, wages for the industry in Nepal including the current liquidity crisis. At times, imported raw materials are more expensive than readymade goods, which discourages the industry. Also, VAT is increasing and the collateral requirement for bank loans in Nepal are very high. Other difficulties faced by the industry are the current environment of high inflation and extremely high interest rates.

On behalf of the RCP, Rtn. Mahendra S. Rawal gave a 'Vote of Thanks' to Mr. Dinesh Shrestha for his presentation and following a Q/A session, President Rtn. Shiva K. Pradhan concluded the interesting session.

Bisht announced: contributions of NRs. 8,900 (NRs. 7,000 to the sunshine fund and NRs. 1,900 to the operational fund of the RCP), and the meeting attendance of 1 visiting Rotarian, 3 guest, 16 members and 9 make-ups.
