- Rtn. Ganesh R. Shrestha briefed on the RCP members' fellowship fund following the RCP's 2nd Birthday Fellowship celebrations.

7. 5th Club Assembly of the RCP:

The 5th Club Assembly of the RCP was held with a review of its activities of past six months and plans for the remainder of Rotary Year 2023-2024. The AG Rtn. Tika N. Lohani had regretted that he could not join due to another commitment, but he is planning to have a meeting of the Presidents and Secretaries of the cluster of four clubs that he is overseeing next Friday.

President Rtn. Mahendra S. Rawal and Chairpersons of the committees made presentations using the 4th Club Assembly PowerPoint presentation as the base. The details of the review will be covered with a revision to the Power Point presentation and shared with all soon. A few of the key observations are shared below:

- Overall, the RCP has done very well in implementing the programmes and activities during the first half of this Rotary Year.
- Concern was raised over the low participation of the members with suggestions on how the RCP could encourage and motivate members to be more active.
- Rtn. Nirmal K. Pradhanang mentioned about the interest of Rtn. Chris O'Brien to work through the RCP on mental health issues, which will be explored.
- Possibility of collaborating with Rtn. Sunil Gupta on his work with autistic children in Birgunj was suggested to be explored with the RCP's KPAD committee.
- Suggestions were made to motivate the Rotaract Club of Patan for joint activities, particularly in the RCP supported schools.
- Suggestions were also made to have new banners and pamphlets for the RCP's PEEF programme and for the Rotary's '4 Way Test' in the supported schools.
- 8. Before the adjournment of the meeting by the President, Secretary Rtn. Shiv P. Khemka announced: happy news contributions of NRs.7,300 (50% of NRs. 3,650 each to the operational and sunshine funds), NRs. 3,100 for attendance to the operational fund of the RCP, and the meeting attendance of 15 members, 1 spouse, and 10 makeups.

Rotary Information

Since the 2024 Rotary International Assembly in early January, participants at Rotary's annual learning event for incoming leaders have been talking a lot about making our Rotary clubs "simply irresistible." This term was used as the title of a 1988 song and a 1999 movie. In terms of Rotary, it was first used by Past District Governor Louisa Horn and recently championed by Stephanie Urchick, 2024-25 Rotary International president.

So what does "simply irresistible" mean in terms of an organization? According to Deloitte's description of "<u>The Simply Irresistible Organization</u>,"TM an irresistible organization has five elements: (i) meaningful work, (ii) supportive management, (iii) a positive work environment, (iv) growth opportunities, and (v) trust in leadership. I truly believe that together, we can make Rotary an irresitible organization if our clubs provide these elements to our members.
